Minimum requirement* (10 points): The Applicant is required to have taught at least 800 contact hours (including at least 100 hours of lectures) at any higher education institution during the ten years preceding the submission of the application. The teaching activity must be certified by the Applicant's direct superior, and the relevant student feedback results for at least the last 5 years must be provided. In the absence of student feedback, the assessment of the Applicant's direct superior is also acceptable. Special criteria for the minimum requirement: Experience in higher education may include lectures, seminars, practice sessions, consultations and, in case of summer practice, sixth-year practice and tutorial activities in vocational education and training, an additional two contact hours per week, irrespectively of the number of students. At least 100 hours of the latter must fall within the five years preceding the submission of the application. In the case of foreign Applicants: instead of the Applicant's superior certifying the contact hours taught, other means of proof used in the particular country are also admissible. For example, a certificate from the dean's office, or an itemised list of the courses which yielded the contact hours stating the course titles, the name of the institution/faculty/subject, the level of education (bachelor, master, doctoral), and the date. With respect to student feedback on teaching activity, the information resulting from the processes of the given country must be taken into account.	10		
Points for teaching activities: 20 points are given for 1000 contact hours, 30 points for 1200 contact hours, 40 points for 1400 contact hours, and 50 points for 1600 contact hours. With respect to teaching activities (1a.1), the minimum requirement is 800 contact hours (including 100 hours of lectures), for which the Applicant is given 10 points. For 1600 contact hours (including 200 hours of lectures), a maximum of 50 points may be given. Between the maximum and the minimum, the score is determined proportionally and must be rounded to the nearest whole number.	40

Outstanding scientific work is assessed on the basis of the minimum requirements set by the Hungarian Academy of Sciences (Section II Philosophy and Historical Sciences, including Psychology) regarding applications for the title Doctor of the Hungarian Academy of Sciences in the two relevant fields (social sciences and natural sciences). The Applicant shall clearly indicate which set of criteria of the two different psychological fields (natural sciences and social sciences (hereinafter respectively A and B) he/she will you choose to assess their outstanding scientific and research work.		
<u>Minimum requirement* (10 points):</u> 75% of the requirements indicated above must be met.		
A) In the case of <i>Natural Sciences</i> : The expected professional impact of scientific output is a minimum of 180 PsychInfo, Medline, Scopus or SCI citations over a career and a Hirsch index (calculated based on independent references) of at least 9 based on these citations (i.e. the number of scientific publications with independent citations greater than/equal to the Hirsch index calculated based on independent references), and a minimum cumulative impact factor of 45.		
B) In the case of <i>Social Sciences</i> : At least 90 points based on the scoring system in the table below and at least 180 citations based on the MTMT database: In the case of monographs, edited books, book chapters: scientific peer-reviewed monographs/textbooks are publications that have been peer-reviewed (edited) and have an ISBN or ISSN. The monograph/book may be printed, electronic or on CD, but in the latter two cases it must also meet the criteria described above.	10

In the case of a Hungarian-language articles, the term "scientific journal" refers to a journal that has an editorial board, the scientific standard of articles are peer-reviewed by anonymous experts and have an abstract in a foreign language. The journal may be printed, electronic or on CD, but in the latter two cases it must also meet the criteria described above.		
Only journals in PsychInfo, PubMed or Web of Science may be taken into account if the article is in a foreign language.		



Article published in international conference proceedings – 2 points		
For this criterion, a full paper published in the "proceeding" of an international conference can be accepted if the "proceeding" meets the criteria for scientific journals (see above).		
Points may be awarded:		
A) In the case of <i>Natural Sciences</i> : Each citation that meets the criteria indicated in the minimum requirement and exceeds the minimum requirement is worth 0.67 points, rounded up to the nearest whole number (e.g. for a total of 210 citations, $30 \times 0.67 = 20$ additional points). The maximum score that can be given here is 40 points – a total of at least 240 citations ($60 \times 0.67 = 40$).		
B) In the case of <i>Social Sciences</i> : Each point awarded on the basis of scoring system B above the minimum requirement is worth 1.334 points (e.g. for a total of 103 B points, $13 \times 1,334$ can be given, which is rounded up to 17 additional points). The maximum score that can be given here is 40 points - a total of at least 120 B criteria points (30×1.334 rounded up to a total of 40 points).	40	
In the case of foreign Applicants: the criteria "foreign language" and "foreign publisher" can be met by a work published in an international journal or by an internationally renowned publisher. In the case of native English-speaking Applicants, publication in another language is not required. In the case of nonnative English speaking Applicants, publication in a (foreign) language relevant to international scientific communication is required.
